EARLY DECISION AGREEMENT

Under the Early Decision Plan, an applicant may apply to only one institution as an Early Decision Candidate. Applicants may apply to other institutions provided that none of the applications are made under an Early Decision or an applicable Early Restrictive Action Plan. The obligation stated here and as defined by the National Association for College Admission Counseling is a commitment on the part of the applicant to withdraw any other applications and to initiate no new applications if accepted under an institution's Early Decision Plan (This commitment is binding only if the institution offers sufficient financial aid). For applicants to the Peabody/JHU Double Degree program, this commitment is binding only if the applicant is admitted to Krieger School of Arts and Sciences or Whiting School of Engineering.

I understand that I may apply only to one institution under a binding Early Decision program and that if admitted under the Early Decision Plan, I will attend that institution (only if sufficient financial aid is offered).
